IMPORTANT: Type or PRINT CLEARLY, using dark ink. Make additional copies of this form as needed. Use of your own format is acceptable (Excel or Word) if ALL information requested is given. Horizontal (landscape) format please. Keep a copy of the completed entry form for your records and enclose a copy with wine shipment. For your security, if you gave credit card info on the entry form, delete it on the shipping copy. If changes must be made after form is sent, fax or email an entry form marked "REVISED", or for simple changes email the change to WinemakerChallenge@yahoo.com. Incomplete or inaccurate information may result in wine not being judged under the best circumstances. We are not responsible for submission or shipping errors. For Name of Wine, include Brand Name if different than Winery, or use separate entry form for each Brand. Make clear the distinction between a Brand Name and a Proprietary Name. Copies of labels clarify this issue, so include one label or legible copy for each wine with entry form. Tech sheets are welcome. Make sure all 6 bottles for each entry are exactly the same wine, vineyard, vintage, etc. (this is a common shipping error). Give size of bottle or container if other than standard 750ml bottle. State the price of the size bottle you are shipping, or explain. Mark the outside of each box "Winemaker Challenge" and indicate total shipped (example: "Box 1 of 3"). To assure proper handling and storage, ship wine only to the Hancock address. Ship wine as soon as possible to allow time to resolve questions or issues, especially if shipping from outside the US. See instructions if you require Customs assistance; Entry form should be sent before wine is shipped to allow time for paperwork to be processed.
